4. In the event that collection proceedings must be instituted to collect any balance due, I may be subject to statutory court costs and attorney fee

6. If applying for a joint account, both of us agree to be bound by the terms of this agreement and each of us agree to be jointly and sever; liable for payment of all purchases made under this agreemen

Co-Energy Alliance shall have the right to limit or terminate my charge account, but termination shall not affect my obligation to pay an existing balanc If I have not paid the amounts billed on two occasions within a 12 month period and fail to cure the default within 15 days after Co-Energ Alliance sends me a written default notice, Co-Energy Alliance may at their option declare the entire balance due and payabl
